FREQUENTLY ASKED QUESTIONS

FAQ #1 – When will applications for the RN Program be accepted?

Applications are accepted Monday through Friday, 9:00 am to 4:00 pm as follows:

Generic

Advanced Placement LVN to RN Military Challenge Advanced Placement January 1 through January 31 each year August 1 through August 31 each year August 1 through August 31 each year

FAQ #2 – How do I get a copy of the RN Program application?

The generic, advanced placement and military challenge applications may be downloaded from the Health Sciences page of the CMC website <u>here.</u>

FAQ #3 – What documents must be in my RN Program application package?

The RN Program application package MUST be submitted in a sealed envelope and MUST include the following:

1. The RN Program application

2. Official unopened transcripts (in original sealed envelopes) for ALL college coursework (including CMC) and post secondary (after high school at a technical school, ROP program etc.).

- 3. Official high school or GED transcripts (in original sealed envelopes).
- 4. Any additional documents listed on the application.

FAQ #4 – How do I submit my complete application package?

You can send your application in via USPS as long as it is postmarked by 1/31 or you can hand carry your application package (in a sealed envelope) to the Health Sciences/Nursing Programs Department (Room 214) on the CMC campus. The sealed envelope MUST be addressed as follows:

FAQ #5 – How will I know if my application has been accepted?

Applicants will be notified by e-mail of the status of their application. The application must contain a valid e-mail address. If no e-mail address is listed or if e-mails are returned because they are undeliverable, no further communication will be made and it will be determined that the applicant is no longer interested in pursuing application to the RN Program. Acceptance of an application does not guarantee admission to the Program.

FAQ #6 – What is the admission process?

- 1. Applicants must submit a complete application package.
- After the application period has ended, each application will be screened for evidence of completion of all prerequisite and co-requisite coursework required for the ADN degree and evaluated using the Chancellor's Office Predictor of Success Formula (Community College Nursing Prerequisite Validation Study).
- 3. Applicants are notified of conditional admission or ineligibility via e-mail ONLY.

FAQ #7 - What if I have completed nursing coursework at another school and want to transfer into the CMC RN Program?

The RN Program accepts nursing courses from other accredited nursing programs in the United States if those courses are determined by the Program Director and have been confirmed through the CMC process to be equivalent. Nursing courses taken in foreign colleges are not accepted. Please refer to the complete admission policies posted on the Health Sciences page of the CMC <u>website</u>.

FAQ #8 – I am a California LVN and I want to become an RN. Can I do that at CMC?

Yes! California LVNs may apply to enter the second semester of the CMC RN Program as an Advanced Placement LVN to RN student. Please refer to the complete Advanced Placement LVN to RN admission policy posted on the Health Sciences page of the CMC website.

FAQ #9 – I have military experience as a medic or corpsman and I want to become an RN. Can I do that at CMC?

Yes! Military Challenge Advanced Placement applicants may apply to enter the second half of the first semester of the CMC RN Program as a Military Challenge student.
